A RESOLUTION
AMENDING RESOLUTION NO. 2025-31 TO UPDATE THE IMMIGRATION

1 **COMMITTEE’S RULES AND PROCEDURES.**

2 **WHEREAS**, on January 13, 1999, the Governing Body adopted Resolution No. 1999-6
3 declaring a policy of non-discrimination on the basis of a person’s national origin and appointing
4 an immigration taskforce; and

5 **WHEREAS**, on January 16, 2002, the Governing Body adopted Resolution No. 2002-3,
6 which renamed the Immigration Taskforce the “Immigration Committee”; and

7 **WHEREAS**, on October 9, 2002, the Governing Body adopted Resolution No. 2002-58,
8 which decreased the number of members on the Immigration Committee from fifteen to nine
9 members; and

10 **WHEREAS**, on October 8, 2014, the Governing Body adopted Resolution No. 2014-82,
11 declaring its “continuous” support for immigrant issues in Santa Fe, the state of New Mexico, and
12 throughout the United States; and

13 **WHEREAS**, on April 30, 2025, the Governing Body adopted Resolution No. 2025-31
14 updating the Immigration Committee’s rules and procedures in various ways; and

15 **WHEREAS**, the Governing Body wishes to amend Sections 4 and 6 the Committee’s rules
16 and procedures as follows:

17 Section 4. MEMBERSHIP AND OFFICERS: The committee shall consist of a
18 Governing Body member city councilor, who shall serve as a non-voting member-representative
19 and, chair who does not count towards a quorum, and nine representatives members residing in
20 the county of Santa Fe and selected from the following areas: human rights, social services,
21 business community, health care, labor organizations, religious community, youth services
22 providers, women’s advocacy groups, educators, and legal services. The members and city
23 councilor representative shall be appointed by the mayor with the consent of the governing body.
24 The ~~[mayor]~~ committee shall appoint the ~~[chairperson and the committee shall designate the]~~
25 chairperson and vice-chairperson from committee membership, not including the city councilor

1 representative.

2 Section 5. TERMS: The members and city councilor representative shall serve for a period
3 of two years. The committee members and city councilor representative shall serve at the pleasure
4 of the mayor and may be removed at any time, with or without cause.

5 Section 6. STAFF LIAISON(S): The City Manager shall designate one or more City
6 staff members including but not limited to one representative from the Santa Fe Police Department,
7 and any other staff as deemed [as] appropriate, serve as liaisons to the committee.

8 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
9 **CITY OF SANTA FE** that the Immigration Committee's rules and procedures, last updated in
10 Resolution No. 2025-31, shall be amended as follows:

11 Section 4. MEMBERSHIP AND OFFICERS: The committee shall consist of a
12 ~~Governing Body member~~ city councilor, who shall also serve as a non-voting ~~member~~
13 ~~representative, and chair who does not count towards a quorum,~~ and nine ~~representatives~~ members
14 residing in the county of Santa Fe and selected from the following areas: human rights, social
15 services, business community, health care, labor organizations, religious community, youth
16 services providers, women's advocacy groups, educators, and legal services. The members and city
17 councilor representative shall be appointed by the mayor with the consent of the Governing Body.
18 The committee shall appoint the chairperson and vice-chairperson from committee membership,
19 not including the city councilor representative.

20 Section 5. TERMS: The members and city councilor representative shall serve for a period
21 of two years. The committee members and city councilor representative shall serve at the pleasure
22 of the mayor and may be removed at any time, with or without cause.

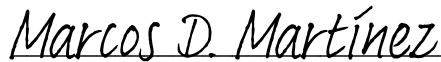
23 Section 6. STAFF LIAISON(S): The City Manager shall designate one or more City
